
Non Refundable Puppy Deposit Agreement



This agreement ("Agreement"), dated as of ______, (the "Effective Date"), is between **Taylor Hirsch** ("**Breeder**") and ______ ("**Buyer**"). Buyer agrees to place a <u>\$ 500.00</u> deposit ("**Deposit**") on a Pembroke Welsh Corgi puppy from the Breeder.

- 1. **Non-Refundable Deposit:** Buyer acknowledges that the Deposit is <u>non-refundable</u> in all circumstances, including but not limited to if Buyer decides s/he does not want or is no longer able to take the puppy. Upon receipt of the Deposit, Breeder agrees to hold the puppy for Buyer until it has been weaned and is ready for pick up. The Deposit shall be made in US Dollars and paid to Breeder via payments through Cash, GoodDog (https://pay.gooddog.com/creme-de-lacreme-corgis) NO Checks, NO Echecks, NO Exceptions.
- 2. Buyer Acknowledgments: Buyer further acknowledges and agrees that (a) Breeder cannot control litter sizes and that the wait time for puppies can be longer than expected; (b) the Deposit gives Buyer a "pick" place, but does not guarantee a puppy or that Buyer's preferences will be available when it is Buyer's turn to pick; (c) pick places are given on a first come first served basis and Buyer's place in line is not negotiable; (d) if Buyer cannot or does not want a puppy from the specified litter Buyer may transfer their deposit ONE time and be placed at the bottom of the pick list for the next anticipated litter that may produce Buyer's preferences; and (e) Breeder cannot and does not guarantee any specific qualities of the puppy when it becomes and adult.
- 3. Buyer's Right to Transfer/Refund: Notwithstanding the foregoing, if a puppy that meets Buyer's identified preferences is not available when it becomes Buyer's turn to pick a puppy from the selected litter, Buyer may elect to have the Deposit transferred to the next litter that may produce Buyer's preferences as a ONE time transfer. The Deposit will only be refundable should something to happen to Buyer's chosen puppy that fatally affects, or makes the puppy unsuitable as a Family Pet while in Breeder's care. The Deposit is forfeit after One transfer has been made and Buyer does not make a pick the second time.
- 4. Final Purchase Price: Breeder and Buyer agree that (a) the Deposit shall be applied to the final purchase price of the puppy and (b) the remaining balance will become due before the puppy is shipped and/or ownership is transferred from Breeder to Buyer. The total purchase price for the puppy is **\$** <u>1500.00</u>. The foregoing purchase price does not include any delivery or shipping charges.
- 5. Governing Law: This Agreement, and all matters arising out of or relating to this Agreement, shall be governed by and construed in accordance with the laws of the State of Missouri without regard to the conflicts of laws provisions thereof.
